## High Tech Scholarships Again Total \$40,000

For the second year, \$40,000 in High Tech Academic Achievement Scholarships will be awarded to deserving AVID students at the May 21 awards dinner. The scholarships are made possible by \$20,000 grants from the USS Midway Museum and the Jack in the Box Foundation.

"No greater investment can be made than one that recognizes and inspires students," said USS Midway Museum's President & CEO, Mac McLaughlin. "Our support of this program is just one aspect of a broader and very effective partnership between Midway and the Classroom of the Future Foundation."

"The Jack in the Box Foundation's focus on improving children's lives is the basis of our support for High Tech Academic Achievement scholarships," added the Foundation's Director, Kathy Kovacevich. "Providing college-education opportunities benefits these students, their families, and our community."

Since 1999, local business and civic organizations have donated nearly \$450,000 worth of scholarships that have been distributed to approximately 250 AVID students across San Diego County.

## SDG&E Extends Partnership With CFF

SDG&E, a charter supporter of the Classroom of the Future, has agreed to be the Innovation In Education Awards title sponsor for the second consecutive year. The financial support is part of a \$1.2 million SDG&E annual investment in STEM (science, technology, engineering, math) initiatives.

In fact, SDG&E made grants to 95 non-profit organizations last year. In a recent *UT-San Diego* profile, CFF's executive director, Bruce Braciszewski, noted "We are proud to partner with SDG&E, and numerous other businesses, community and education leaders, on giving our students all the tools they need to succeed in the global economy."

SDG&E also has active internship and summer camp programs, spanning a

wide range of ages. Another SDG&E program enabled San Diego’s 42 school districts to reduce their electricity consumption by 7.4 million kilowatt hours last year.

## Innovation Day at New Library

The Third Annual Innovation Day will be held at the new downtown San Diego Library on February 20 from 9 a.m. to 2 p.m. The invitation-only event is co-sponsored by the San Diego County Office of Education and Classroom of the Future Foundation.

More than 250 education and business leaders will attend and discuss the latest uses of education technology. The program augments CFF’s annual innovation awards dinner each May by showcasing remarkable uses of technology that may not otherwise receive an award.



## i21Now Benefits from CFF Role

The San Diego Unified Board of Education is turning to CFF and others to forge high-level recommendations that will advance the use of educational technology in the years to come.



CFF is well-represented, as several of its board members are with companies that are recognized as key education technology leaders. CFF board members representing Apple, Cox Communications, Qualcomm, Intel, Time Warner, AT&T and Sony are all part of the i21Now initiative. This also demonstrates how CFF has been successful in building a board of directors comprised of many of San Diego’s leading education/business stakeholders.

In addition, Bruce Braciszewski is co-chairing the broadband subcommittee. Its mission is to develop macro-view recommendations on the future use of wireless technology, access and equity for all students, connecting home, school and community through broadband, and making high-speed broadband affordable.

Other committees will focus on curriculum and professional development; digital tools and policy; facilities; finance; and infrastructure. After an organizational meeting last December, the committee was given 90 days to make its recommendations.

The i21Now program received the CFF’s impact award in 2013.
